(ii) दलित, पिछड़े, अल्पसंख्यक, आदिवासी एवं आर्थिक रूप से कमजोर लोगों को स्वरोजगार के प्रति जागरूक करने हेतु कम्प्यूटर शिक्षा, तकनीकी शिक्षा यथा टी.वी., रेडियो, इलेक्ट्रॉनिक, टंकण प्रशिक्षण, सिलाई-कटाई-बुनाई प्रशिक्षण, मॉडिंग, लघु-कुटीर प्रयोग प्रशिक्षण, आदि की व्यवस्था करना। उन्हें ग्राम विकास संबंधी एवं अन्य कल्याणकारी कार्यक्रमों की जानकारी उपलब्ध कराना। इस हेतु सेमिनार, गोष्ठी, कार्यशाला आदि आयोजित करना।

# BY - LAWS OF KHUSNUMA EDUCATIONAL SOCIETY

Reg no - 26/2007-08

## AIMS AND OBJECTS

1. THE AIM AND OBJECTS AND PURPOSES for which the society is established are as under: -

- (i) To establish, promote, set-up, maintain, administer and manage directly as advise by the society established or in any part of India, School, Hospitals, Super Specialty Research Facility in frontier areas of life sciences, medical colleges, engineering colleges, dental colleges, management colleges, professional/ technical training institution(s), school or vocational institution(s) on or from which students may obtain education and instruction.
- (ii) To support, advise, maintain and/or grant aid or other financial assistance, continue educational institution(s), such as engineering colleges, medical colleges, Super Specialty Research Facility in frontier areas of life sciences, dental colleges, management colleges, professional/technical training institution(s), school or vocational institution(s) of any class or category without any discrimination with any class or section or gender of the society.
- (iii) To function with a non-profit making intention. However, if profit arises that shall be exclusively used or retained for the development of the institution(s).
- (iv) To run a Deemed University, if approved by the Competent Authority.
- (v) The Board of society members ~~will~~ be free to approach any established chain of institutions or franchisee status. Institution(s) will run as per terms and agreements as well as law as approved by Board of society member.

- (vi) To provide lecture classes examination rooms, laboratories, libraries, boarding, lodging and others facilities for students, faculty members and others including facilities for study, research, cultivation, recreation, teaching and performance of the duties allotted to them respectively.
- (vii) To grant monetary assistance and/or loans, stipends, free or subsidized boarding or lodging facilities to deserving student upon such terms and for such periods as society member may decide.
- (viii) To perform all such other lawful acts and thing either alone or in conjunction with other organization(s) or persons as the society may consider necessary or incidental or conducive for attainment of all or any of the above mentioned functions and objectives of the society.
- (ix) To manage and maintain the said institution, the society will have their own fee structure, which must be approved by the Board of society member and the same will not be exorbitant.
- (x) The institution will ensure quality education.
- (xi) The institutions will follow the rules and regulation as may be enforced by the society, from time to time
- (xii) The institutions shall be entitled to raise funds by way of loans, donations and contributions. The discretion and decision of the Board of society member will be final.
- (xiii) To establish, maintain and run boarding houses and residential institutions for the students and persons connected with educational institution(s).
- (xiv) To develop healthy as well as critical attitude towards the development of mental, physical and moral upliftment of the students and those associated with those institutions.
- (xv) To train and equip the public so as to be self-supporting in an honorable and decent way of life so as to develop into good healthy, and progressive citizens.
- (xvi) Society may publish magazines, books, papers and may have any copyright, license title, right or interest therein.
- (xvii) Society may graanize any examination, test, and interview or set any other mode or decide any other way of selection of faculty members, students, staffs or others.
- (xviii) To develop disciplinary conduct and habits to observe the rule of law and be self-restraint.
- (xix) To grant relief to the people affected by earthquake, flood, fire, famine pestilence and other natural calamities of similar nature and to give donations, subscription, and contribution to institutions, establishments or persons doing such relief work.

- (xx) To give financial assistance to poor people through micro financing and such other bodies engaged in such other Public Utility Services.
- (xxi) To arrange, construct and run pyous for thirsty people in the areas where drinking water is scare.
- (xxii) To contribute towards the maintenance of any temple or any religious institution etc. notified by the Central Government to be eligible for deduction under the provisions of section 80G of the Income Tax Act, 1961.
- (xxiii) To render assistance and /or grant aid to recognized public charitable society or institution(s).
- (xxiv) To establish, promote, set-up, run, maintain, assist, finance, support and/or aid to or help in the setting up and / or maintaining and/ or running schools and other institutions for orphanages, widow homes, lunatic asylums, poor houses or other establishments for relief and/or help to the poor, old and infirm people and/ or destitute.
- (xxv) To establish promote, support, maintain, help, run and grant aid/or other financial assistance to dispensaries, hospitals, Super Speciality Research Facility in frontier areas of life sciences, nursing, homes, maternity homes, child welfare centre, sanatoriums, clinics, laboratories, mobile medical units, ambulances, medical and /or surgical campus and other establishments for giving medical relief to the public.
- (xxvi) Society may carry Rural development work.
- (xxvii) Society may carry on or undertake any other work, things which Board of Trustee may decide from time to time for direct/ indirect benefits of the institution or accomplishment of any object of the Trust.
- (xxviii) It is expressly provided that area of operation of society activities may extend to any part of India as deemed fit by the society member.
- (xxix) That the society or the institution(s) run or supported by the society will carry out educational activities or any other activities as mentioned above but will not work-in any way prejudicial to the interest of society.

### MANAGEMENT OF SOCIETY

2. The management and control of the society and the society properties shall vest in society member which shall comprise not less than two and not more than five society member including Precedent.

- (i) All the society member will be collectively known as Board of society member

- (g) If the society member files a petition for being adjudicated as an insolvent or adjudged as an insolvent, or if he or she compounds with creditors.
- (h) If the society member resigns the office of the society by notice in writing under his or her hand left at the registered office of the society.

### MEETINGS

#### 3. Meetings:

- a) The society shall ordinarily transact their business in a duly convened meeting which should take place at least once during every six months. All the meetings of the society shall be held at such place and such time as the President of the society decides from time to time. In case of urgency, any business can be transacted by any written circular to be issued by or at the instance of the President of the society and circulated among the society for recording their opinion in writing on matters under consideration. The vote of majority shall prevail at their meeting or on a voting by circular as aforesaid. The President of the meeting shall have an additional or casting vote in case of equality of votes.
- b) The society shall keep and maintain proper minutes book in respect of all the meetings of the society, and of all circulars resolutions passed by them from time to time and other necessary books and records. The minutes book will be signed by the President of such meetings or on the following meeting when they are read over and when so entered and signed, be conclusive evidence of business and other matter transacted at such meeting.
- c) One third of the total members or two society, whichever is higher, present at any meeting shall form the quorum at all meeting of the society.
- d) All the meetings shall be chaired by the President or in his absence by any other society member elected to chair of the meeting.

### POWER AND FUNCTION OF THE SOCIETY MEMBER

- a) The society shall have all the powers and authorities of the Society, as indicated below and as may be authorized by law:
  - To accept any donation, contribution, grant or subscription in cash or kind including any property from any person, body of person, company or institution on such terms and conditions as the society may deem fit.

- b) To apply whole or part of the income of the society Fund or accumulation thereof or whole or part of the corpus of the society fund for any one or more of the objects of the society as the society member may decide from time to time.
- c) To invest and keep invested the Trust fund or the income thereof either in purchase or mortgage of immovable property or in such securities and investments whether authorized by the Indian Society Act, 1888 or not or to keep in deposit with or loan to such entities as is in conformity with the provisions of Income Tax Act, 1961 for the time being in force, and to alter, vary or transpose such investments from time to time as the Society may in their discretion think fit and proper.
- d) To covert and deal with the society property and/or to vary the investment for the time being.
- e) To borrow money for the purpose of the society and management of its properties from Bank, Government and/or non-Government Financial Institution(s), Private and/or public entities or individuals.
- f) To sell, vary, transpose, dispose off, alienate or otherwise deal with any property movable or immovable comprising the Trust fund or any investment representing the same and to re-invest the same in any manner as the society member may think fit.
- g) To open current and/or saving account with any bank or banks in the name of the Trust, to operate such account and to give instructions to the bank that such account may be operated upon by one or more of the society or by one or more agents appointed by the society.
- h) To adjust, settle, compromise, compound, refer to arbitration all actions, suits, claims, demands and proceedings regarding the properties.
- i) To appoint constituted attorneys or Agents and to delegate to such attorneys or agents all or any of the powers vested in them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.
- j) To appoint or make provision for appointments any person (including all or any of the society) as member of committee or as administrator or Managing society or otherwise for the purpose of the administration of the society as such.
- k) To establish, promote, manage, organize or maintain or to assist in establishing, promoting, managing organizing or maintaining any branch of the society or any other society or its branch with

- (ii) The Corporate society will be represented by their appointed representative. The representative of the corporate society will be required to submit their authority letter duly authorizing them to attend the board meetings. Without such authority letter the representatives will not be allowed to attend the Board meetings.
- (iii) The society shall be chargeable only for such moneys, stock, shares, and funds as shall actually come into their hands and they shall not be answerable or accountable for neglect, default, acts of omission or commission of other society nor of any banker or other persons with whom the society properties or any securities may have been deposited or kept unless caused by their will full neglect or default.
- (iv) The society will not be entitled to receive any remuneration as society but may reimburse themselves of all expenses actually incurred by them in connection with the society or their duties relating thereto.
- (v) Upon the appointment of a new society, the society funds shall vest in the new society jointly with the continuing society with the power and subject to the society thereby created.
- (vi) If any society resigns, dies, retires, becomes unfit or incapable to act, the continuing or surviving society will be competent to appoint society in the place of society resigning, dying, retiring or becoming unfit or incapable to act either for life or otherwise as aforesaid.

#### VACATION OF OFFICE BY SOCIETY MEMBER

5. The office of the society shall be vacated-

- (a) If the society dies or becomes of unsound mind or in case of corporate Trustee is wounded up.
- (b) If the society without leave of absence, does not attend three consecutive meetings of the Board of Trustees or for one calendar year whichever is longer.
- (c) If the society is adjudicated insolvent.
- (d) If the society willing to resign.
- (e) If the society is convicted of criminal offence involving moral turpitude.
- (f) Any member may resign by giving notice in writings to his co-member.
